A complete set of Bidding Documents may be purchased from the office of **Tripurasundari Rural Municipality, Piskar, sindhupalchowk** by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of **Nrs 3,000.00(Three Thousand Rupees only) till 15th Magh during office hour**
4. Pre-bid meeting shall be held at **office of Tripurasundari Rural Municipality, Piskar, Sindhupalchowk at 13:00 hr on 5th Magh 2077.**
5. Sealed bids must be submitted to the office of **Tripurasundari Rural Municipality, Piskar, sindhupalchowk** by hand on or before **12:00 hr on 16th Magh 2077**. Bids received after this deadline will be rejected.
6. The bidswill be opened in the presence of Bidders' representatives who choose to attend at **13:00 hr on 16th Magh 2077** at the office of **Tripurasundari Rural Municipality, Piskar, sindhupalchowk**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security amounting to a minimum of **NRs 2,93,000.00 (Two Lakh Ninty Three Thousand Rupees only)**, which shall be valid for 30 days beyond the validity period of the bid .
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
